## TRANSPORTATION GUIDELINES

Professionally hired transportation is the most desirable method to be utilized for any trip and whenever possible, this mode of transportation should be provided. The use of private passenger vehicles should be avoided, if possible. If a private passenger vehicle must be used, then the following information must be faxed to Cari at (208) 342-1571 and kept on file by the parish/school driver coordinator. The driver must certify this information.

### 11-15 passenger vans are NOT allowed per diocesan policy

- 1 The driver must be 21 years of age or older.
- 2 The driver must have a valid, non-probationary driver's license and no physical disability that could in any way impair his/her ability to drive the vehicle safely.
- 3 The vehicle must have a valid and current registration and valid and current license plates.
- 4 The vehicle must be insured for the following minimum limits: \$100,000 per person/\$300,000 per occurrence/ \$100,000/property. A combined single limit (CSL) of \$300,000 is acceptable.
- 5 The driver must complete the Defensive Driving Curriculum noted on the Driver Information Sheet.
- 6 Copies of VALID DRIVER'S LICENSE, INSURANCE and CATHOLIC MUTUAL GROUP'S CERTIFICATION that the Defensive Driving Curriculum has been completed and passed must be supplied to the Diocese for Diocesan events and to the Parish for parish events.

A signed **DRIVER INFORMATION SHEET** for each vehicle used must be submitted to the parish/school driver coordinator prior to the trip. The coordinator will fax this to the diocese.

*–This form should be faxed to Cari at (208) 342-1571 by 5 days before driving or  
driver may not be authorized to drive.*

*A copy should be kept on file by the parish or school*
